PRESIDENTS COLUMN FEBRUARY 2013

In this issue we showcase member John Creel who was a "First Generation" Special Forces Soldier who was assigned to the 10th Special Forces Group (A) in Germany during the late 1950's. CSM Berry is planning on sending a team for the 2013 GBSC although there is no federal funding. All travel and accommodations will be at team expense. Hopefully we can locate several sponsors to support active duty teams.

Mike Keele's article on the 2012 Green Beret Shooters Cup is in final layout for publication in the Soldier of Fortune Magazine.

Mike has been working closely with LTC Robert K. Brown, the publisher, and Mike had mentioned a very unique combat experience that one member of a 2012 Team had experienced. Well it looks like Mike stuck his neck out and has been asked to write about the event for the S.O.F. Magazine. A FORMER GREEN BERET'S LOVE FOR HIS WIFE AND A PASSION FOR RUNNING MARATHONS

Interview Conducted by Terry Cagnolatti

On January 10, 2013, I sat down with John Creel a member of Special Forces Chapter 78 who has a true love for his wife of 53 years, Ingrid; and a passion for running.

John stated that he joined the United States Army in October 1954, and completed jump school, at Fort Benning Georgia, in 1955, where he was recruited for the US Army Special Forces, also known as the "Green Berets." John's Military Occupational Specialties (MOS) were Communications and Demolitions.

In March 1957 John was deployed to Bad Tolz, Germany and assigned to the 10th Special Forces Group. While assigned to the 10th Group Creel completed language school-yes, you guessed it – German. John met his wife Ingrid in Munich, Germany in 1958 and they were married in 1959. A year later they moved back to the United States where John was honorably discharged at Fort Hamilton, New York in 1961.

John has been retired since completing a combined 40 years working for both the General Electric Company and Kaiser Hospital as a sales representative and x-ray technician respectively.

While working out at his local gym in 2004 and at the age of sixty-seven (67) John

met a group of young women who were training to walk/run a half marathon at the Los Angeles Marathon event. Two women of the group were Margaret Chau and Jean Gardner who eventually became his running partners along with Denis Paez and Kevin Kilcoryne. John thought it would be fun to join in the race; however he had not run much since his military days. John said of the race, "I did fine for the first eight miles but cramped up and it took me forty minutes to run the last four miles."

However, John did not give up on running, as in true Special Forces tradition. He continued to train with a group called. "A Snail's Pace," there John connected with a group of friends. On October 10, 2004 John ran his first full 26.2 mile marathon race. It was then he fell in love with running and set a goal to run a marathon in each one of the fifty states in America. After the Long Beach Marathon on October 10, 2004, Creel ran the Boston Marathon on April 18, 2006, starting his quest of the fifty states. (Continued on page 4)

As John left to compete in each state, he found himself facing another challenge. John's wife Ingrid was diagnosed with Multiple Sclerosis in 1988, her condition has grown progressively worse with each passing year, John stated, "Ingrid can neither stand, walk nor feed herself; she has not been able to walk since 1995." Each time John left California to compete in an out of state race he would hire a local live- in caregiver to be with Ingrid for the duration of his trip, usually two or three days at a time. John stated, " it became clear that these arrangements were not working out because he learned Ingrid was not getting the proper care." She would at times remain in bed for John's entire trip. Both John and Ingrid decided that it would be best for her, Ingrid, to accompany him on each out of state marathon. John researched and found a caregiver that would provide proper care for Ingrid in each one of the states they traveled to.

The company is called "A Place for Mom" ran by Trish Bossow, a caregiver Franchisee who lives and works near Ft. Worth, Texas. "Trish has provided us with extremely reliable care-giver options for over three years; I cannot over state how much she has helped us."

On November 15, 2009, Ingrid accompanied John for the first out of state marathon which was held at San Antonio, Texas and forty-four marathons afterwards. John and Ingrid also participated together in races as John would push Ingrid in her wheelchair in four 5 K races over the last two years.

John Creel completed his goal of the fifty state marathons on October 13, 2012 at Hartford, Connecticut where he placed second in his age group (see photos) at the age of seventy-six years old and has completed a total of 60 Marathons.

John has placed over the entire period of competing in his age group first in twenty two races, second in thirteen races, and third in nine races.

I asked John, what was your favorite or best race? He immediately answered "New York," because of the crowd. We ran through five boroughs and the crowds were electrifying. John added, he also ran past Fort Hamilton where he was honorably discharged from the service in 1961, which was exciting. I then asked John what was his least favorite or most challenging race? John replied Green River, Wyoming, stating "because the course went from 6,000 feet to 7,050 feet in 3 miles, almost straight up. We had to turn around and come down the

same road, a very difficult race."

John Creel is an inspiration to Americans of all ages not only for his tenacity and discipline in completing over sixty marathons at the young age of seventy-eight, but more so for the love of his wife Ingrid.

In 2009, John and Ingrid returned to Germany with a large group of family members to renew their wedding vows after fifty years of marriage at the same chapel where they were married in 1959.



JOHN STRYKER MEYER ADDED TO BOARD OF AFFORDABLE COMMUNITY LIVING (ACL)

AIR VIETNAM CRASH NHA TRANG, VIETNAM — 12-22-69



Submitted by Brad Welker, this is a picture of a crash that took place in Nha Trang, RVN 22 December 1969. The Air Vietnam passenger plane ran off the runway at the Air Base there. Ironically it struck a jeep as it ran off the field containing SFC Richard V. Williams of Delta Project (B52) who was seriously injured and medically evacuated to Japan where he died of the injuries about a month later.

The Victoria Club was a bar frequented by lower ranking American GI's. The information below describes the events. The civilian deaths included bar girls and children in an adjacent "school".

Summary: An explosive device was detonated in the cabin just as the aircraft was about to land. The blast damaged the aircraft's hydraulics. The aircraft became airborne, overran the runway and crashed into a school.
